O1 Opening remarks by the Chairman:

Dr. Ramani, in his opening remarks extended greetings to all the members and in particular welcomed Prof. N Bijoy Singh, VC, Manipur University, who had come all the way from Imphal in spite of his physical inconvenience. Heexpressed a sense of happiness about the progress made by the Centre in extending UGC-Infonet to 142 Universities and also the services under the Ejournal Consortium covering about 4600 full text scholarly journals/titles to over 100 universities in a phased-manner. He also complimented the efforts of the Centre in carrying out a large number of Library Management (SOUL) Software installations across the country in a record time, thereby earning substantial revenue for the Centre. He remarked that all these have been achieved by the Centre under the able leadership of Dr. T A V Murthy, Director and committed members of his team who worked tirelessly in spite of various constraints including acute manpower shortage. He also appreciated the role of INFLIBNET for creating awareness about its programmes and services across the country and mentioned that with the new competencies built by the Centre in facilitating the execution of the prestigious national projects like; UGC-INFONET & E-JOURNAL Consortium launched by UGC, the Centre will be stepping into the area of College Networking and plans to provide the Colleges with electronic journals in the near future. He further remarked that so much has taken place

He felt that there is a big constraint of losing of trained manpower from time to time at INFLIBNET due to lack of growth/promotional avenues and said that for this the Commission's support is needed in a big way. He further suggested to the distinguished members to express their views. Dr. Ved Prakash, Secretary, UGC, while complimenting the Director and his team emphatically mentioned the commendable work done by the Centre and advised that henceforth the Centre may plan conducting more training/awareness programmes so that the services/facilities of INFLIBNET are made use of by larger academic communities. Further, he suggested that the Centre may make special efforts for optimizing the consortia services including E-Contents etc. at the national level by collaborating with INDEST and other consortia. Prof. Bijoy Singh expressed the same feelings and further added that the tremendous efforts put in by Dr. Murthy and his team in reaching out to all the North-Eastern states is admirable in spite of hostile environment in some of the places in the region. The PLANNER, Awareness Programmes, Library automation and Workshops organized by INFLIBNET are welcome sign to bring this area into the mainstream. He advised that such efforts be continued. Dr. Nupur Prakash also joined the distinguished members in complimenting the INFLIBNET under the leadership of Dr. Murthy and appreciated the special initiatives taken by INFLIBNET in providing a large number of electronic journals for the benefit of researchers and academics across the country and in particular the automation and networking of libraries of the colleges of North Eastern region and J&K state under the special drive in spite of various operational difficulties.

The members noted the actions taken by the Centre on the action items generated in the last meeting and expressed satisfaction on all the items.

04 Status Report

The Members debated on the status report reflecting all the developmental, newer initiatives and achievements of the Centre presented by Dr. Murthy and expressed their happiness and satisfaction.

O5 Supply of SOUL to institutions Outside India:

The agenda submitted by the Centre on the subject was considered by the Chairman and all the members and it was felt that the expertise of Indian professionalism and academic endeavyors be extended to all the SAARC countries. It was, therefore, unanimously agreed by the Board to supply SOUL Library Software to these countries at the same cost at which it is being supplied in India and hoped that this will bring respectability to the country. At that point of time, Prof. Nupur Prakash, suggested that Mauritius which is an Indian

Ocean country and affiliated to Association of Indian Universities (AIU) may also be supplied the SOUL Library Software. This was unanimously agreed and Director was advised to put efforts in supplying SOUL to these countries only for the present and not to other countries.

The Director raised the issue of enhancement of remuneration to the SOUL Coordinators and technical staff which was duly approved by the Board long back but still awaiting clearance from UGC. The members requested UGC to accord speedy approval to the same to enable the Centre to coordinate this activity effectively as it is losing the trained manpower because of better career opportunities elsewhere. The Director also requested approval for appointment of 4 additional Coordinators along with the support staff in the areas falling in Bengal, Orissa, Hindi speaking and North-Eastern States on the existing terms and conditions. He informed that due to operational difficulties, the SOUL Coordinator appointed for western region and located at Ahmedabad showed his inability to continue due to his old age and as such the support staff attached with him was shifted to the Centre and appointed on contractual basis to provide support for SOUL related activities, which was agreed by all the Members. The Members expressed unanimous views that the Centre should bring out the next new version of SOUL Library Software at the earliest with additional improved features and work out a suitable policy incorporating the Annual Maintenance Contract (AMC) and other strategy for implementation, keeping in view of the ever growing demand.

O6 Filling up of vacant
Scientific/Technical Posts:

After considerable debate on the topic and keeping in mind the hardship faced by the Centre in meeting the challenges and taking up of additional responsibilities due to the shortage of technical manpower, the members requested the Commission to help by suggesting at least some interim measures to overcome the alarming situation. At this juncture, Dr. Ved Prakash, Secretary, UGC and Dr. P Prakash, Jt. Secretary, UGC, informed that a "One man Committee" "has been set up by the Commission who has already visited 3 other IUCs for assessing the staff strength and manpower requirement and will be visiting INFLIBNET on 15th of September, 2005 after visiting CEC, New Delhi, on 14th of September, 2005. Dr. Ved Prakash also informed that there is another Committee set-up by MHRD, Government of India, to review the activities of IUCs which has already visited few IUCs and is likely to visit INFLIBNET in near future. On receipt of recommendations of these two Committees, the Commission will be in a position to take appropriate decision in the matter including appointment of manpower on contractual basis to mitigate the hardships faced by the Centre. Besides, the Secretary suggested that INFLIBNET should prepare a PowerPoint presentation covering all its important activities, achievements and future projections and keep it ready for submission to the MHRD Committee when it visits the Centre.

07 Promotion Policy for Scientific & Technical Staff:

There was considerable debate on this issue. JS, UGC, apprised the Board that INFLIBNET has been put in the category of Service oriented Centre along with two other IUCs viz. CEC and NAAC. At that point of time, Director pleaded that it is most unfortunate that the Centre, which has produced impressive results, quality publications of high repute in national and international journals and carried out pioneering R & D/Scientific work to bring out comprehensive Library Mangement (SOUL) Software with latest features/updation and state-of-the art technology, which has earned respectability by way of its presence in more than 800 installations across the country and generated substantial revenue for the Centre has been termed as Service Centre.

In addition, he stated that INFLIBNET has a unique distinction of executing the UGC-Infonet with direct involvement in the universities in the area of Computer Networking, Telecommunications and effective execution and monitoring of the gigantic E-journal Consortium by providing full-text journals to the Universities in the country and its larger bibliometric status cannot be equated with a service oriented Centre. He further submitted that USA National Institute of Software Organization, BIS etc. have invariably referred high quality standards to INFLIBNET for vetting which is recognition to the Centre and UGC at International level.

He also mentioned that a large number of technology-oriented/specialized workshops, conferences, seminars etc. are conducted by the Centre and the same show the in-built capabilities of INFLIBNET's scientific character. All the members were pleased over this submission and unanimously agreed and requested the Commission to re-categorize the Centre as a Scientific organization and extend all the benefits including complimenting flexible promotion to the technical staff as has been extended to some IUCs (who have been categorized as Scientific organizations).

08 Extension of GPF-cum-Pension Scheme For Staff:

After going through the agenda item and the representations submitted by the senior-most Scientist Shri S M Salgar, Scientist-G and Shri C K Shah, Admn.Officer (GS) of the Centre, the Board debated the issue at length and expressed concern about the consequences that are likely to affect the long serving staff of the Centre, if the GPF-cum-Pension scheme is withdrawn. The Board unanimously urged the Commission to take it up again with Government for reconsideration and favourable decision. The Board also suggested to the Centre to again submit a proposal with full details to the Commission with the recommendations made by the Board in the matter.

Grant of financial up-gradation: under the Assured Career Progression Scheme (ACP) to all eligible employees (Technical as well as Administrative) of the Centre from due date as per the orders of Govt. of India on the subject.

The Board was apprised about the Assured Career Progression Scheme (ACP) introduced by Government of India for the Central Government employees with the orders issued by the Government on the subject. After debating on the topic and as recommended by the Finance Committee, the Board accorded its approval for implementation of the ACP and grant of financial up-gradation to all eligible employees (Technical as well as Administrative) of the Centre in accordance with the directives of the Commission and orders of the Government of India on the subject.

Payment of leave salary and pension contributions to Central Institute of English and Foreign Languages (CIEFL — a Deemed University), Hyderabad for the period of lien granted by them to Dr. T A V Murthy, to take up the appointment of Director of the Centre.

After going through the proposal submitted by the Centre as contained in the agenda and obtaining certain clarifications from the Director, the Board strongly recommended that the Centre as a borrowing organization should discharge pensioner liabilities in paying leave salary and pension contributions to the parent organization of Dr. Murthy i.e. CIEFL for a tenure of 5 years and in order to maintain his lien in CIEFL, payment of these contributions is essential in his case. The Board further advised the Centre to submit a proposal in the matter to the Commission and obtain clearance for making the payment as per

JUSTIFICATION FOR DISPOSING OFF ITEMS

1. Stabilizers (0.5 KVA & 1 KVA):

Seven nos. of these stabilizers were being used in laboratories on ground floors. During rainy season of 2002 there was flooding in the campus and these stabilizers remained water logged for few days. They have become unserviceable and may be disposed off.

2. Modem (2.4 Kbps):

This is a very low-speed modem, used many years back for dialing into ERNET node at Bombay for e-mail purpose. This is technically obsolete item and may be disposed off.

3. Dot Matrix Printer (3 Nos.):

These printers were procured about 10 years back and are unserviceable now. They may be disposed off.

4. LCD Plate:

This LCD plate was procured more than 8 years back. This plate is damaged and cannot be repaired. Further since now the Centre has new state-of-the-art projectors, this type of equipment is not required. So it may be disposed off.

Fax Modem (14.4 Kbps):

This is a low speed modem procured 10 years back. Due it is low speed, it is not usable now and is technically obsolete. It may be disposed off.

6. **Tape Drive:**

It was purchased more than 9 years back and is not being used, as it is unserviceable. It may be disposed off.

External CD Writer 7.

This CD-Writer is unserviceable and cannot be repaired. This may be disposed off.

8. **CD-Drive**

This CD-Drive was procured more than 12 years back and is not in use as it is unserviceable. It may be disposed off.

9. **Cannon Xerox Machine:**

This Xerox machine is more than 7 years old. It often breaks down, in spite of repeated repairs. It's life seems to be over. It may be disposed off.

Revolving Chairs (Computer): 10.

These two chairs are totally broken and cannot be repaired. They may be disposed
